ASSISTED DYING AND ABORTION How do political parties measure up?

Right to Life's challenge to all election candidates – will they sign either "Both lives matter" pledge or "Vote to do no harm"

Right to Life https://righttolife.org.uk/ have constructed an email to go to all candidates in any constituency asking them to declare their views on ABORTION and on ASSISTED DYING ("Both Lives Pledge") and another just on ASSISTED DYING ("Vote to do no harm pledge").

Application of our faith comes into play in that we know God values all life and that these 2 issues challenge what God says.

Their *Vote To Do No Harm* campaign about "Assisted Dying" It states:

After the general election, the assisted suicide lobby, led by pressure group *Dignity in Dying*, is likely to make a major attempt to introduce assisted suicide. The *Vote To Do No Harm* campaign's main goal is to get as many people as possible to ask their MP candidates to sign the *End-of-Life Protection Pledge*. Candidates who sign the pledge commit to vote against any attempts to introduce assisted suicide or euthanasia and support the provision of better palliative care for people at the end of their lives.

Awareness raising:

<u>ABORTION:</u> For your information – to decriminalise abortion means repealing the 1861 "Offences against the person Act" which then negates the 1967 "Abortion Act" which simply amended the 1861 Act. Sadly the "conscience clause" is in the 1967 Act, so would be lost, forcing all doctors to be involved in abortion.

ASSISTED DYING: In Canada there is no "conscience clause" in their Assisted Dying law ("Medical Aid in Dying" – "MAiD") forcing Christian doctors and health care professionals, and also institutions such as Hospices, to carry out terminating life rather than offering good end of life care.

Thank you for your email regarding abortion and assisted suicide.

These are both clearly complex and emotional issues, with strongly held views on both sides of the debate.

I have always believed in a woman's right to choose, and that abortion should be treated as a healthcare issue between a woman and her doctor, rather than a matter for criminal law. With regard to assisted dying, it is clear that our current laws are not working for many people at the end of their life and that there is strong public support for reforming them. As it stands, people only have a choice about how to end their life if they are fortunate enough to have the money and the physical strength to travel. This is not right.

However, I also understand concerns about how we could ensure the right safeguards are in place. We should never risk a situation where people could be coerced into agreeing to assisted dying against their will. Equally, assisted dying should not become an alternative to high-quality palliative and end of life care. People deserve dignity in dying, and each person nearing the end of their life should feel reassured that they will receive the very best care. This is not the case at present, and that needs to change.

Successive governments have taken the view that any change to the law on this should be a matter of conscience for individual MPs. As such, this places a responsibility on MPs to get to grips with this issue, listen to evidence, experts and those with lived experience. Like other issues which will be seen as matter of conscience, I would support a future Labour Government making time for Parliament to decide any changes in the law on this issue. Ultimately, I remain open-minded on this issue and am committed to making my decision on the basis of available evidence.

Thank you for contacting me and sharing your views – which I will keep in mind.
